## SIGN-IN, WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT PHOTO AND VIDEO RELEASE FORM

During this course, participants will learn techniques to predict and prevent violence. Participants are taught to trust their instincts, recognize manipulative behaviors and how to use their voice and physical skills (including self-defense techniques) to run, yell and tell in order to get help. The course includes a discussion of mature subjects relating to assault, abuse and recognizing signs of unhealthy relationships.
